SUBJECT: 2023 Approved Budget, Reserve Disclosure, and 2023 Board Meeting Dates

### 1. 2023 Approved Budget

Enclosed is the approved 2023 budget. The Board has voted to raise the dues to \$275.00 per quarter. This increase is primarily done to add in a line item for tree maintenance, as there will be an ongoing need for pruning and removals due to the age and size of the trees in the common areas. Please keep this budget with your other important HOA documents. You will continue to receive quarterly statements in the mail prior to the due date.

## 2. Reserve Disclosure

The Virginia Code requires community associations to provide information about the funding of reserves as a part of the annual budget. A copy of the Association's reserve study prepared in 2016 for a 2017 study year is on file with the Association's management company, and the update is currently being worked on. The reserve study contains data on the estimated remaining useful life and cost of replacement of the Association's capital components.

The 2017 reserve study recommends that the total balance of the reserve fund should be \$55,578 as of January 1, 2023. As of September 30, 2022, the current balance of the reserve fund is \$55,076. The 2017 reserve study also recommends an annual contribution to the Association's reserve account for fiscal year 2023 in the amount of \$9,136.00.

The 2023 operating budget includes an annual contribution of \$9,136.00. The Board of Directors has adopted the cash flow method for calculating reserve funding. The procedures used for estimation and accumulation of cash reserves are addressed in the 2017 reserve study.

# 3. 2023 Board Meeting Dates

The Board meets quarterly in the Market Café in Wegman's at 7:00pm. The schedule for 2023 is January 26, April 27, July 27, October 26.

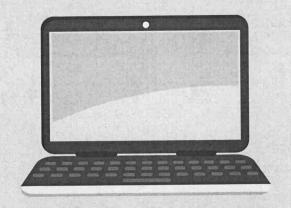
