

# **Pool Rules and Regulations**

The following rules have been revised and established for the benefit of all users of the Pool to assure the safe operation of the Pool facilities and to provide enjoyable recreation for all. Patrons are requested to cooperate in observing these rules. The Pool company employees and members of the Board of Directors have authority to enforce all Pool rules. Patrons violating swimming rules are subject to the revocation of their use of Pool area privileges.

The Board of Directors, Management Company, and Pool Management Contractors reserve the right to refuse admittance into any VRL HOA recreational facility when the capacity of the area has been reached or when otherwise deemed necessary for the health, welfare or safety of its patrons.

The Association and the Board will not be responsible for enforcing social distancing measures or safe practices by users of these amenities.

# **Pool Rules:**

Residents use the Pool facilities at their own risk. The Association, the Board of Directors, its agents, or assigns assumes no responsibility for any accident or injury in connection with such use or for any loss or damage to personal property.

Anyone who is experiencing symptoms of COVID-19 (including fever, cough, shortness of breath, headache, muscle/body aches, loss of taste/smell, sore throat,runny nose, nausea, vomiting, or diarrhea) is required to avoid use of these amenities and seek medical attention.

- 1. The Pool facilities are reserved for residents and guests of VRL ONLY.
- Each resident must sign the COVID waiver and send a copy to the Management Company to keep on file prior to being granted access to the pool and other amenities. Once received the access card will be activated.
- 3. Residents must sign in and out any guests. All guests must sign a Covid Waiver.
- 4. Any unvaccinated residents or guests (except under the age of 2) are required to wear a mask while on the Pool deck, or when entering the restrooms or Clubhouse. Masks should not be worn while swimming.
- 5. Residents and guests must use hand sanitizer to properly clean their hands prior to entering the Pool facility.
- 6. Residents and guests are required to wipe down lounges, chairs, tables, and other furniture prior and after using.
- 7. Patrons should maintain a minimum distance of six (6) feet from other patrons.
- 8. Proper attire is required.
- 9. Anyone under the age of 16 must be accompanied by an adult.
- 10. Neither the VRL HOA, Community Management nor Association assumes liability for injuries or damages. Due to the strenuous nature of some Pool activities, participants are advised to consult a physician prior to conducting such activities. Pool related activities present certain inherent risks and hazards which participant assumes.

- 11. No person is permitted in the Swimming Pool Area/Pool Facility unless it is officially open, and the lifeguards are on duty.
- 12. Persons under the influence of alcohol or drugs will not be permitted in the Pool complex or in the surrounding area, as determined by the Pool Management Staff.
- 13. No person within the Pool grounds shall behave in such a manner as to jeopardize the safety and health of himself/herself or others. Such behavior, including abusive or profane language and excessive public displays of affection, shall be grounds for expulsion.
- 14. Loitering will not be permitted on the Pool grounds or within any of its facilities.
- 15. Any injury occurring in the Pool area must be reported to the lifeguards on duty immediately. Call 911 in case of emergencies.
- 16. Pool company employees, Board Members, management, and contractors are the only persons allowed in the guard room, filter room, mechanical room, and storage room.
- 17. The use of cameras, video cameras or any device containing camera equipment of any kind is prohibited in all bathrooms and changing facilities.
- 18. Running, boisterous or rough play, pushing, acrobatics, dunking, wrestling, splashing, yelling, diving or jumping haphazardly, snapping of towels, improper conduct causing undue disturbances in or about the Pool area or any acts which would endanger any patron are prohibited.
- 19. Spitting, spouting of water, blowing nose, or urinating in the Pool is prohibited.
- 20. Non-swimmers must remain in shallow water (chest deep or less).
- 21. **No diving** is permitted.
- 22. Only persons that have been certified by the American Red Cross to teach swimming may utilize the Pool to provide swimming instruction. No activity for private gain is permitted at any time.
- 23. The Association requires that children not toilet trained wear a **swim diaper covered by tight fitting waterproof pant or a swimsuit** in either Pool. Absolutely no changing of diapers on the Pool deck.
- 24. Noodles, infant life vests, water wings that are Coast Guard certified are acceptable at the sole discretion of the Pool Management Company.
- 25. Glass drink containers are prohibited. Only plastic, unbreakable, spill proof containers or bottles are allowed.
- 26. Pets are prohibited in the Pool area.
- 27. Smoking is prohibited in the Pool area and clubhouse.
- 28. Radios, CD players, iPod and MP3 Players may be played only at a volume that does not disturb others.
- 29. Chairs may not be reserved for persons who leave the Pool area. They are available on a first come, first serve basis. Please return chairs to their original position and clean around you before leaving the Pool area.
- 30. Proper respect and cooperation are due to the lifeguards and attendants, who are to provide for the safe and orderly operation of the Pool.
- 31. The Pool may be closed at any time due to inclement weather (rain, thunder, lightning, etc.), breakdown of equipment, operational defects, or other unavoidable causes.
- 32. For the protection of all Residents, admission to the Pool area may be denied for Residents or Guests with open lesions, sores, infections, skin abrasions or contagious conditions.
- 33. The lifeguards may demand any patron leave the Pool area and/or Pool/Clubhouse privileges may be revoked if the rules are not being followed.
- 34. Changes to the Pool Rules and Regulations and/or hours of operation are at the sole discretion of the Board of Directors and subject to modification and/or change by the Board of Directors.

35. Any member delinquent in payment of their HOA assessments will not be issued access cards or be permitted access to the Pool or other amenities.

# **IN CASE OF EMERGENCY CALL 911**

If you lose your original access card, there will be a replacement fee of \$10.00 per individual pass.

Please note: Assess cards can take up to 7 days to process.

Guests are defined as person(s) who do not reside in VRL.



# **Fitness Center Rules and Information**

This publication sets forth the policies and rules for use of the Fitness Center/ Clubhouse of the Association.

HOURS: Everyday 5:00 AM to 10:00 PM

The following rules have been revised and established for the benefit of all users of the Clubhouse/Fitness Center to assure the safe operation of the facility and to provide enjoyable recreation for all. Patrons are requested to cooperate in observing these rules. Patrons violating facility rules are subject to the revocation of their use of Fitness Center area privileges.

The Management Company, Board of Directors, and/or Association Contractors reserve the right to refuse admittance into any VRL HOA recreational facility when the capacity of the area has been reached or when otherwise deemed necessary for the health, welfare or safety of its patrons.

The Association and the Board will not be responsible for enforcing social distancing measures or safe practices by users of these amenities.

# **Fitness Center Rules:**

Residents use the fitness center at their own risk. The Association, the Board of Directors, its agents, or assigns assumes no responsibility for any accident or injury in connection with such use or for any loss or damage to personal property.

Anyone who is experiencing symptoms of COVID-19 (including fever, cough, shortness of breath, headache, muscle/body aches, loss of taste/smell, sore throat, runny nose, nausea, vomiting, or diarrhea) is required to avoid use of these amenities and seek medical attention.

- 1. The Fitness Center is reserved for residents of VRL ONLY.
- 2. Each resident must sign the COVID waiver and send a copy to the Management Company to keep on file prior to being granted access to the facility. Once received, the access card will be activated.
- 3. Only 6 people will be allowed in the Fitness Center at a time.
- 4. If there are patrons waiting to use the Fitness Center please limit your time to no more than 1 hour.
- 5. Residents are required to use hand sanitizer to properly clean their hands prior to using the equipment.
- 6. Residents are required to wipe down equipment prior to use and after using each piece of equipment.
- 7. Residents should maintain a minimum distance of six (6) feet from other Fitness Center users.
- 8. Proper attire is required.
- 9. Residents must bring their own drinks for hydrating.

- 10. Anyone under the age of 16 must be accompanied by an adult.
- 11. Neither the VRL HOA, Community Management nor Association assumes liability for injuries or damages. Due to the strenuous nature of some exercise activities, participants are advised to consult a physician prior to conducting such activities. Exercise related activities present certain inherent risks and hazards which participant assumes.
- 12. No person is permitted in the Fitness Center/Clubhouse unless it is officially open.
- 13. Persons under the influence of alcohol or drugs will not be permitted in the Fitness Center complex or in the surrounding area.
- 14. No person within the clubhouse grounds shall behave in such a manner as to jeopardize the safety and health of himself/herself or others. Such behavior, including abusive or profane language and excessive public displays of affection, shall be grounds for expulsion.
- 15. Loitering will not be permitted on the Clubhouse grounds or within any of its facilities.
- 16. The use of cameras, video cameras or any device containing camera equipment of any kind is prohibited in all bathrooms.
- 17. Individuals shall not monopolize a particular piece of equipment and thereby limit its use by or intimidate other patrons.
- 18. Alcohol and glass drink containers are prohibited. Only plastic, unbreakable, spill proof containers bottles are allowed in the Fitness Center.
- 19. Food may not be consumed in the Fitness Center.
- 20. Pets are prohibited in the Fitness Center/Clubhouse.
- 21. Smoking is prohibited in the Fitness Center/Clubhouse.
- 22. Radios, CD players, iPod and MP3 Players may be played only with earphones, at a volume that does not disturb others.
- 23. Changes to the Fitness Center Rules and Regulations and/or hours of operation are at the sole discretion of the Board of Directors and subject to modification and/or change by the Board of Directors.
- 24. Any member delinquent in payment of their HOA assessments will not be permitted access to the Fitness Center/Clubhouse.
